Program Features

- 01 Online Discovery Workshop** – The process begins with a three-hour, online workshop used to identify potential areas of improvement. We start with a high-level walkthrough of your current implementation to understand how the system is used today, then work through our checklist to capture new program goals, surface new ideas and discuss how new ProcessUnity features could be incorporated into current processes.
- 02 Recommendations / Plan** – Based on the information gathered in the Discovery Workshop, our Customer Success expert will develop a plan to be executed in the Onsite Workshop.
- 03 Onsite Workshop** – The real work happens during the two-day Onsite Workshop. In conjunction with your application administrator(s), our Customer Success expert will work to implement the approved recommendations, training your team in the process. Any additional areas for improvement identified while onsite will be prioritized as time permits.
- 04 Health Check Report** – Following the Onsite Workshop, our team will compile a summary recap of the Health Check. The report includes a detailed summary of the actions taken plus any additional recommendations that your team can perform to continue tuning after the engagement.
- 05 Online Debrief Workshop** – Within two weeks of the Onsite Workshop, we'll meet to review the Health Check Report and take a final walk through your instance. We'll complete the three-hour session by highlighting the new capabilities built into your program and answer any outstanding questions.
