

## **Solution Components**

Vendor Identity Intelligence is comprised of six components: ProcessUnity Vendor Risk Management platform, D&B's D-U-N-S Search, D&B's Beneficial Owner Search, the ProcessUnity D&B D-U-N-S Search Connector, the ProcessUnity D&B Beneficial Owner Connector and a combination of pre-built workflows, notifications, reports and dashboards to power vendor due diligence, third-party assessments, issue tracking and remediation and ongoing monitoring processes.

D&B's D-U-N-S Search uses input criteria to find the best candidates in its extensive database of business entities. It uses a proprietary algorithm to identify the best matches and returns relevant matches with detailed information about what criteria was used to find the match. The D-U-N-S Search follows the below three steps:

- Cleanse, parse, and standardize
- Retrieve candidates
- Evaluate and decide




D&B's Beneficial Ownership List identifies both vendors and individuals and indicates their relationship to the specified D-U-N-S Number to identify an organization's Ultimate Beneficial Owners (UBOs). ProcessUnity's connectors seamlessly integrate D&B's D-U-N-S Search and Beneficial Owner Search by passing parameters from ProcessUnity to Dun & Bradstreet. The connector presents lists of the best matches within the ProcessUnity platform, eliminating the need to access multiple applications or manually look for information on each entity. To automate intelligence and add objectivity into the onboarding and continuous monitoring processes, this information from D&B is incorporated into search grids to help inform thirdparty managers of the best candidate to select. Thirdparty risk managers can then select the correct candidate to initiate automated workflows for continuous, ongoing vendor monitoring, issue creation and management.

Vendor Identity Intelligence is built on ProcessUnity's Best Practice Program for Vendor Risk Management – a complete, proven third-party risk program with turn-key workflows, assessments, calculations, risk analysis and reporting.
