ProcessUnity Platform Certification

ProcessUnity's certification testing program is intended for experienced application administrators (customers, partners, and employees) that measures individual knowledge of the configuring the ProcessUnity platform. The exam is generally agnostic from any implemented solution but slanted towards TPRM (third party risk management). There are two certification programs and designations:

1. **Certified ProcessUnity Platform Specialist (CPPS)** - The *first level* of certification tests general platform knowledge via a timed examination of multiple-choice questions. Administrators who pass this exam are awarded a "specialist" certificate valid for two years.
 - CPPS testing began May 2022
2. **Certified ProcessUnity Platform Expert (CPPE)** - The *second level* of certification that evaluates expertise through a variety of live challenges made up of short configuration challenges, contextual questions, and hands-on labs. Administrators who pass this exam are awarded an "expert" certificate valid for two years.
 - CPPE exams are only offered to administrators who have passed the CPPS
 - **CPPE program development is underway and not yet available**

Both certification exams are focused on demonstrating "platform experience," which includes knowledge of ProcessUnity's specific nomenclature, object model, feature set, and general platform capabilities. Understanding the nuances of what the platform *cannot* do is just as important as understanding what it can do. It is the knowledge of this nuance that allows successful administrators to effectively understand business requirements, design/build solutions that meet those requirements, and most importantly be able to confidently participate in conversations with clients and prospects about platform capabilities.

Earning a ProcessUnity certification is equivalent to a *black belt* for administrators, as it demonstrates to the world that this designation is worthy of esteem and respect regarding a specialized skillset implementing the ProcessUnity platform.

- ✓ Certification validates skills; improves **individual** career potential and marketability.
- ✓ Certification allows **customers** to scale their ProcessUnity solutions more easily.
- ✓ Certification validates **partner** effectiveness/maturity as a trusted system integrator

This study guide lays out the prerequisites and minimum learning requirements necessary to prepare and take ProcessUnity's CPPS certification exam.

CPPS Exam Format

The CPPS exam is an online, timed test comprised of multiple-choice questions where no two tests are identical.

- a) The exam is taken online via ProcessUnity’s learning system (LMS).
- b) Multiple-choice format, 100 questions (single-select, multi-select, True/False).
- c) Questions are randomly chosen from a growing 250-question database.
- d) Multi-choice options for each question are randomly sequenced / presented.
- e) The exam has a time limit of 60 minutes to complete.
- f) Do not leave any answers blank. If you are unsure of an answer, use with your best guess, and review later as time permits. Blanks are graded as incorrect.
- g) Questions are presented one at a time and can be revisited prior to submitting.
- h) Once submitted, the exam will be closed, and your score will be shown.
- i) A formal response will be emailed out within 3 days of completing the exam.
- j) An 80% accuracy score is required to pass the exam.
- k) Retries may be taken after a 7-day wait period. There is no limit to retries.

Passing the CPPS Exam

Individuals who pass the CPPS exam will be awarded a PDF certificate (personalized and sent via email). Those who wish a physical (embossed) certificate may request one (mailed upon request).

The CPPS distinction is valid for 2 years from issue date and can be renewed by taking the exam again at that time.

Those who pass the CPPS are encouraged to add “*ProcessUnity CPPS*” to their email footer (with a provided CPPS logo) and update their social media status accordingly. For example, by adding this designation to their *LinkedIn* profile in the Licenses and Certifications section.

The future exam (CPPE) will award individuals with a separate certificate, emblem, and possibly a physical award (details to be announced when the CPPE program becomes available).

The exam tests knowledge of the ProcessUnity **platform** – generally agnostic from any implemented solution – though a small portion of the test does focus on TPRM topics. Administrators may wish to rate their abilities on each topic below to determine exam readiness.

CPPS Exam Difficulty



Is the exam difficult?

Both the CPPS and CPPE are reflections of an administrator's experience and comfort level single-handedly configuring and implementing solutions on the ProcessUnity platform.

It is recommended that new administrators gain real-world experience before seeking ProcessUnity platform certification. **Certification is intended to be a distinction that separates new administrators from seasoned specialists/experts.** For this reason, ProcessUnity does not wish to employ a *simple* exam that diminishes the value of a passing grade. Those who earn a CPPS certificate join a distinguished group of individuals and should feel proud of this accomplishment.



Part of the CPPS exam's difficulty is the speed at which questions must be answered. With 100 questions to answer in a 60-minute, admins have (on average) about 30 seconds to read and answer each question. Answering 2 questions every minute would take 50 minutes, with a 10-minute review.

Note, some questions are "multi-answer" which are more difficult than "single-selects." To get credit for these questions, all correct options must be chosen without selecting any incorrect options.

CPPS Exam Preparation



How can I prepare for the CPPS?

Below are the best methods to prepare for the CPPS exam.

1. **ProcessUnity Learning Center (LMS)** – ProcessUnity’s LMS is currently available for customers, partners, and employees based on specific programs they are registered for. This Learning Center provides recorded content on a variety of topics, with quizzes and homework that help reinforce the material. The courses that are helpful for CPPS readiness include:

 - **Customers** – gain experience by enhancing/scaling your own solutions.
 - **Partners** – gain experience by working on multiple client implementations.

Proctoring

ProcessUnity may be using online proctoring software for "exam security" in its certification exams to discourage cheating, as a deterrent to protect ProcessUnity's intellectual property (the exam itself) and protect ProcessUnity's brand / reputation. These proctoring tools reduce friction and stress from the testing experience, allow the examination to be taken virtually (online), and help to keep ProcessUnity's IP safe. Not all exams, however, will be formally proctored in this manner.

When in use, proctoring tools/mechanisms employed may include:

- a. Shared screens during testing process, to capture the inappropriate use of other screens/windows.
- b. Camera to capture gestures and head/eye movement looking for and capturing inappropriate behavior when focus should be on the exam window.

When proctoring tools are being used, all recorded proctoring content is deleted after the exam has been officially graded and results disseminated.

Ready to Get Started?

Registering for the CPPS exam is done via <https://www.processunity.com/certexam> and clicking “register” to start the process.

Registering

1. Register for the exam.
2. Receive an email with a special link to access the exam.
3. Take the exam anytime within 30 days of receiving the email.

Taking the exam

1. Some exams will be proctored, meaning it will require you to turn on screen sharing and webcam. If proctored, instructions will be provided.
2. Once you “start” the test you must finish (or wait 7 days to try again).
3. By taking the exam, you are attesting to ProcessUnity’s “honor code” and not cheat (in any way) or access any external help, systems, or individuals when taking the test.
4. Once you’ve answered all the questions, you will submit your exam.
5. Results (pass/fail and score) will be shown immediately, with a follow-up email sent separately (1-3 days later).

Those who pass

1. Join the growing and distinguished list of certified ProcessUnity professionals!
2. A signed CPPS Certificate will be emailed to you, along with a CPPS graphic for your email footer.
3. A physical embossed CPPS Certificate (and a cloth CPPS patch) will be sent to you upon request.
4. Your certification expires in 2 years -- retake the exam then to maintain your status.

Those who do not pass

1. Ask for a retest, which will be available 7 days from the last attempt.
2. Then try again. There is no limit to the number of retakes.
